The following disclosures are required by the Federal Electronic Signatures in Global and National Commerce Act ("ESIGN"). They are necessary to open your account electronically; you can record your consent to the ESIGN disclosures by clicking ACCEPT TERMS located at the bottom of this page.

## **Electronic Delivery of Disclosures**

By clicking ACCEPT TERMS below, you are consenting to electronically receive The Bank of Hemet Online Banking Agreement and Disclosure required by the Electronic Fund Transfers Act and Regulation E.

## **System Requirements**

To receive and retain an electronic copy of The Bank of Hemet Online Banking Agreement and Disclosure, you must have the following equipment and software:

- A personal computer or other device which is capable of accessing the Internet. Your access to this page verifies that your system/device meets these requirements.
- An Internet web browser which is capable of supporting 128 Bit SSL Encryption, such as Microsoft Internet Explorer 6.0 or higher, Netscape Navigator 6.1 or higher, Mozilla Firefox 1.0 or higher or Opera 7.54 or higher.
- A printer and/or the ability to download pdf files in order to keep a copy for your records.
